| <p><b>SELF-EMPLOYMENT<br/>INCOME SUPPORT<br/>SCHEME INCLUDES:<br/>SHARE FISHERS</b></p> | <p>If you are self-employed or a share fisher earning taxable profit of less than £50k p.a. and are adversely affected by Covid-19 you are entitled to a grant worth 80% of average monthly taxable profit, up to £2,500 a month for three months, or longer if necessary. Taxable profit is income after business expenses have been deducted from annual turnover.</p> <p>If you missed the 2018/19 tax filing deadline in January, you have been given extra time - up to April 23 - to submit a tax return for that year</p> <p>You can receive this grant and continue to do business, or claim Universal Credit and other benefits and still qualify for the grant..</p> <p>You cannot apply just yet – HMRC will contact those eligible and invite them to apply online through gov.uk</p> <hr/> <p><b>For guidance, please <a href="#">click here</a></b></p> |
| <p><b>UNIVERSAL CREDIT</b></p>  | <p>Universal Credit has removed the Minimum Income Floor which makes it easier for self-employed people to access this benefit.</p> <p>Self-employed earners may be eligible for either new style Job Seekers Allowance (JSA) or Universal Credit or both. | <p><b>INCOME TAX</b></p>  | <p>Self-assessment income tax payments have been deferred from end of July 2020 to end January 2021. This is an automatic offer with no applications required. | <p><b>VAT</b></p>   | <p>VAT payments deferred from end March 2020 to end June 2020. This is an automatic offer with no applications required. | <p><b>HMRC COVID-19 SUPPORT FOR BUSINESS</b></p>            | <p>Businesses with outstanding tax liabilities and in financial distress can receive extra support through HMRC's Time to Pay service. | <p><b>CORONAVIRUS BUSINESS INTERRUPTION LOAN SCHEME</b></p> | <p>This scheme will help businesses who have immediate cash-flow issues. | <p><b>MARKETING INITIATIVES</b></p>                         | <p>Food is part of the Critical National Infrastructure (CNI) and sea fishing is a key element of the food chain. Fishers are reviewing their business operations and making the best decisions for them and the safety of their crew as to whether to continue fishing, with appropriate social distancing measures in place, or tie up. There is no compulsion on them either way.</p> <p>If you wish to sell privately, private buyers can purchase up to 30 kg of fish caught from a licensed fishing vessel for private consumption. Restaurants and commercial buyers are required to be registered.
